**ORDINANCE NAMING A ROAD SEGMENT LOCATED OFF  
CAMP BETTY HASTINGS ROAD WITHIN THE UNINCORPORATED AREA OF  
FORSYTH COUNTY, "TRACTOR TRAIL"  
(MAPFORSYTH/CITY-COUNTY GEOGRAPHIC INFORMATION OFFICE)**

**WHEREAS**, the MapForsyth/City-County Geographic Information Office, Addressing Team requested a road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County be named, "Tractor Trail"; and

**WHEREAS**, the Addressing Team of MapForsyth/City-County Geographic Information Office received no opposition to the proposed road name from the adjoining property owners; and

**WHEREAS**, the proposed road name complies with the requirements of the adopted Addressing and Street Naming Guidelines and Procedures Manual as approved by the Addressing Technical Committee consisting of Emergency Management, Emergency Services, Sheriff's Office, WS Fire, and WS Police, among others, and therefore, does not pose any address range or road name duplication issues; and

**WHEREAS**, pursuant to the provisions of N.C.G.S. 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road segment, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

**NOW, THEREFORE, BE IT ORDAINED** by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named "Tractor Trail".

**BE IT FURTHER ORDAINED** that after naming "Tractor Trail", Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law.

**BE IT FURTHER ORDAINED** that this Ordinance shall become effective upon its adoption.

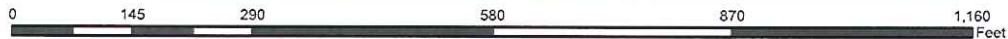

### **Staff Recommendation – Naming of Tractor Trail**

The Forsyth County Addressing Policies and Procedures Manual requires any driveway which serves as the primary means of ingress or egress for three (3) or more occupiable buildings or other facilities to be named. A property owner requested to build a new residence on a fourth lot accessed by an existing easement already serving three other dwellings which prompted the Addressing Team to require the easement to be named. The applicant completed a petition to name the easement off of Camp Betty Hastings Road to “Tractor Trail.” This street name has been approved by the MapForsyth Addressing Team and all other effected property owners have been notified by mail of the naming to “Tractor Trail.” Staff recommends approval of this proposed street name.

Chestnut Street in Winston-Salem, N.C. pursuant to the provisions of N.C.G.S. 153A-239.1 on a proposed ordinance to name a road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County, "Tractor Trail".

This notice shall be published once at least ten (10) days before the public hearing date in a newspaper of general circulation in Forsyth County, and prominently posted at the County Courthouse and in at least two public places in the municipality nearest the road location.
