(COMMUNITY AND ECONOMIC DEVELOPMENT)**

**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:** Recommend Approval

### SUMMARY OF INFORMATION:

In 2015, the Forsyth County Board of Commissioners adopted a Resolution authorizing a total of \$4,000,000 in County funds be reserved from the General Fund to support the redevelopment of Whitaker Park. The \$4,000,000 consists of \$2,350,000, approved at the September 28, 2015 Board meeting, for future Reimbursement Agreements with WPDA, Inc., and \$1,650,000, approved at the December 21, 2015 Board meeting, for the purchase of a building at the park. The Board approved a reimbursement agreement in the amount of \$1,768,576 on November 28, 2016, and an amendment to that agreement on February 15, 2018 to increase the reimbursement by \$155,630.12. An amended agreement was not executed by the end of FY2017-2018 and the funds were not encumbered. The unencumbered funds returned to the committed fund balance in the general fund on June 30, 2018.

This Budget Ordinance Amendment appropriates the \$155,630.12 from committed fund balance in the general fund for the Whitaker Park projects in Fiscal Year 2018-2019.
