**NOTICE OF
PUBLIC HEARING ON A PROPOSED ORDINANCE NAMING AN

Notice is hereby given that Forsyth County will conduct a public hearing on Thursday, October 4, 2018, at 2:00 p.m. in the Forsyth County Commissioners' Meeting Room on the Fifth Floor of the Forsyth County Government Center located at 201 N. Chestnut Street, Winston-Salem, NC pursuant to the provisions of N.C.G.S. 153A-239.1 on a proposed ordinance to name an unnamed road segment, located off Sedge Garden Road within the unincorporated area of Forsyth County, "Fair Lane."

**ORDINANCE NAMING AN UNNAMED ROAD SEGMENT LOCATED OFF
SEdge GARDEN ROAD WITHIN THE UNINCORPORATED AREA
OF FORSYTH COUNTY, "FAIR LANE"
(MAPFORSYTH ADDRESSING TEAM)**

WHEREAS, MapForsyth staff requested the naming of a road segment located off Sedge Garden Road within the unincorporated area of Forsyth County, "Fair Lane"; and

WHEREAS, the Addressing Team of the MapForsyth staff received no opposition from the adjoining property owners to the road naming; and

WHEREAS, the proposed road name does not pose any address range or road name duplication issues; and

WHEREAS, pursuant to the provisions of N.C.G.S 153A-239.1, at least ten (10) days prior to conducting the public hearing to rename the said road, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road renaming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

NOW, THEREFORE, BE IT ORDAINED by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the road segment located off Sedge Garden Road within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named "Fair Lane".

BE IT FURTHER ORDAINED that after naming "Fair Lane", Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the NC Board of Transportation, and to any municipality within five miles of the said road as required by law.

BE IT FURTHER ORDAINED that this Ordinance shall become effective upon its adoption.
