**RESOLUTION DESIGNATING NEW REVIEW OFFICERS TO
REVIEW AND CERTIFY MAPS AND PLATS FOR
FORSYTH COUNTY, NORTH CAROLINA, IN ACCORDANCE
WITH N.C. GENERAL STATUTE 47-30.2
(CITY-COUNTY PLANNING AND DEVELOPMENT SERVICES DEPARTMENT)**

WHEREAS N.C. General Statute 47-30.2 requires that the Forsyth County Board of Commissioners designate by name one or more persons experienced in mapping or land records management as Review Officers to review and certify maps and plats as required before being presented for recording in the office of the Register of Deeds;

WHEREAS a Resolution Designating Review Officers as required by the said General Statute was adopted by the Forsyth County Board of Commissioners on September 22, 1997, and recorded in the office of the Register of Deeds in Deed Book 1966, Page 2795, and most recently revised by the Board in the latest resolution adopted August 17, 2017, and recorded in Deed Book 3364, Page 16; and

WHEREAS changes in the staff of the City-County Planning and Development Services Department and other jurisdictional agencies require that new Review Officers be designated for Forsyth County, North Carolina.

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that the following persons are now hereby designated by name as Review Officers for Forsyth County, North Carolina, in accordance with the provisions of N.C. General Statute 47-30.2:

BE IT FURTHER RESOLVED, that this resolution, once adopted, shall be recorded in the office of the Register of Deeds of Forsyth County, North Carolina and indexed on the grantor index in the name of each Review Officer, and that no map or plat, required to be submitted for review, shall be recorded in said office of the Register of Deeds without an affixed certification of a designated Review Officer as identified above pursuant to the provisions of said General Statutes. Once adopted, this resolution revokes all previously approved plat review officers who are not listed in this resolution.
