On November 13, 2019, the City/County Purchasing Department received bids for the purchase of two half-ton pickup trucks for use by the General Services Department as follows:

**RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF TWO

**WHEREAS** on October 31, 2019, the City/County Purchasing Department issued bid invitations for two half-ton pickup trucks to be used by the Forsyth County General Services Department to 16 local and regional qualified businesses;

**WHEREAS** bids were received and publicly opened by the City/County Purchasing Department at 12:00 PM on Wednesday, November 13, 2019, for the purchase of two half-ton pickup trucks per bid specifications at the request of the Forsyth County General Services Department and the following bids were received:

**WHEREAS** the lowest bid is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3);

**WHEREAS** the County Manager, the County General Services Director, and the City/County Purchasing Director recommend that a contract for the purchase of two 2020 Ram 1500 pickup trucks per bid specifications in the amount of \$25,357 each be awarded to Horace G. Ilderton, LLC, for a total contract amount of \$50,714;

**NOW, THEREFORE, BE IT RESOLVED**, by the Forsyth County Board of Commissioners, that a contract for the purchase of two 2020 Ram 1500 pickup trucks per bid specifications is hereby awarded to Horace G. Ilderton, LLC, in the total amount of \$50,714 and that all other bids are hereby rejected, and that the County Manager and Clerk to the Board are hereby authorized to execute a contract with Horace G. Ilderton, LLC, for the purchase of such vehicles in a total amount of \$50,714, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
