Dear Mr. Terry:

You were sent a letter from the State Board of Elections on January 8, 2002 requesting that you amend your Committee's disclosure report to contain contributor information that is required by N.C.G.S. §163-278.11(a)(1). You were sent a letter on January 23, 2002 requesting that you provide copies of contributions made to your campaign from Marshall B. Bass and James T. Lambie. You have not complied with either of these requests. We have also tried to reach you by telephone and have been unsuccessful.

Mr. Bass provided a copy of his contribution to your Committee and a determination has been made that the contribution was from personal rather than business funds. However, you have not provided a copy of the contribution to your Committee from Mr. James Lambie. If you do not have a copy of the check, a copy can be requested and obtained from your bank. If you do not provide a copy of the check, a determination will be made that the contribution was made in cash, thereby violating N.C.G.S. §163-278.14(b).

Please furnish a copy of the requested check within 5 business days. In addition, please amend the enclosed disclosure report to reflect the information required by North Carolina State law. If you will not be able to fulfill this request, please call the undersigned at the State Board of Elections at 919-715-7173 immediately to discuss this situation. We appreciate your cooperation in this matter.
