No entity shall give, and no candidate, committee or treasurer shall accept, any monetary contribution in excess of one hundred dollars (\$100.00) unless such contribution be in the form of a check, draft, money order, credit card charge, debit, or other noncash method that can be subject to written verification.  
Violation appears on CRO-1210, page 1, for Bobby Blakely, Jr. for \$150.00 in cash.

**Decision:** Per the State Board of Elections audit specialist, the treasurer should return the contribution of \$150 to Mr. Blakely. The contributor may deposit the check and give a contribution back to the committee in cash if \$100 or under; or, write a check if they wish to give over that amount.
