After receipt of the First Plus report, I spoke to Mr. Mark Williams, treasurer for the Committee to Elect Lonnie Maines for Sheriff on April 19, 2006. Further explanation was needed for the \$678 cash entry of a fund raiser on the CRO-1205 of the enclosed copy of this report. Per this telephone conversation to Mr. Williams, the entry was described as a "pass the hat' fund raiser where attendees donated whatever they wished to the committee. I explained to Mr. Williams that this seemed to be a violation of NCGS 163-278.14: No contributions in names of others; no anonymous contributions; contributions in excess of one hundred dollars. At this time, I called Jason Schrader, Audit Specialist for the SBOE, for advice. Mr. Schrader agreed and advised that any funds that were anonymously given should be paid to the State Board by check to the Civil Penalty and Forfeiture Fund of the State of North Carolina. This disbursement would appear on the Second Quarter Report. Mr. Williams was told this in a subsequent phone call.
