A meeting of the Forsyth County Board of Elections was called to order in the 2<sup>nd</sup> Floor Board Room on Tuesday, November 5, 2024, at **2:08** p.m., Chairperson Robert Durrah, Jr. presiding.

## **Approval of Absentee Ballots**

Macy Payne, Absentee Ballots Manager, presented 432 civilian absentee ballots, 79 affidavit pending ballots, 31 overseas ballots, 21 military ballots, and 7 accepted cure ballots for review and approval. Member Draper moved to approve the 431civilian absentee ballots and 79 affidavit pending ballots; Secretary Doomy seconded. **Motion carried unanimously.** 

Secretary Doomy moved to approve 7 accepted cure and 10 pending absentee ballots; Vice Chair Jourdan seconded. **Motion carried unanimously.**

Member Draper moved to approve 31 overseas ballots and 21 military ballots; Member Harvey seconded. **Motion carried unanimously.**

Mrs. Payne presented 42 witness issues ballots, 17 pending cure, and 1 spoiled ballot envelope for a total of 60 disapproved ballots for the Board to review. Secretary Doomy moved to disapprove the 60 total ballots; Member Harvey seconded. **Motion carried unanimously.**

Write-in votes tallied.

Ballots that did not scan in the high-speed central counter due to tears, folds, or water damage were marked spoiled. The board members duplicated the ballots that were spoiled, and the ballots were properly scanned through the high-speed central counter.

Board Members signed Zero Reports for the DS450 high-speed scanner.

Mrs. Payne presented 18 military ballots for review and approval. Secretary Doomy moved to approve the 18 ballots; Member Draper seconded. **Motion carried unanimously.** 

Mrs. Payne presented one VIP (visually impaired person) ballot for review and approval. Secretary Doomy moved to approve the one ballot; Member Draper seconded. **Motion carried unanimously.**
