# **Meeting Called to Order**

A meeting of the Forsyth County Board of Elections was called to order in the 2<sup>nd</sup> Floor Board Room on Thursday, October 3, 2024, at **2:00** p.m., Chairperson Robert Durrah, Jr. presiding.

## **Approval of Absentee Ballots**

Macy Payne, Absentee Ballots Manager, presented to the Board the updated absentee problems and solutions reference sheet for the Board's review and approval. Secretary Doomy moved to approve the updated absentee problems and solutions reference sheet as presented; Member Draper seconded. **Motion carried unanimously.** 

Mrs. Payne presented a total of 309 civilian, 22 overseas, and 7 military absentee ballots for approval. Secretary Doomy moved to approve a total of 338 absentee ballots consisting of 309 civilian, 22 overseas, and 7 military absentee ballots.

Mrs. Payne presented a total of 9 civilian absentee ballots for disapproval.

Member Adam moved to amend the previous motion for the approval of absentee ballots and to approve 313 civilian, 22 overseas, 7 military absentee ballots and to reject 9 civilian absentee ballots; Secretary Doomy seconded. **Motion carried unanimously.**
